



CEO Commitment Form to Participate in the Just Culture for Patient Safety Collaborative

The goal of the Collaborative is to provide an in-depth understanding of Just Culture principles and to facilitate the adoption of those principles in achieving a robust safety culture in a learning organization. As part of the Collaborative, each participating hospital will work to optimize the use of Just Culture principles to improve organizational safety culture.

To assist hospitals on this journey, the Collaborative will offer education, resources, and expertise to help hospital teams develop and apply a Just Culture Algorithm to reinforce Just Culture principles to create a culture of learning that sustainably reduces risk and improves patient safety.

COLLABORATIVE ACTIVITIES:

LAPS PSO members will be invited to participate at no cost in a seven-part webinar series throughout the year that will focus on Just Culture for Patient Safety.

Participants will be able to:

- Participate in monthly calls beginning with the kickoff on Feb. 15;
 - Other Tentative Call Dates: March 15, April 26, May 17, June 21, Sept. 20, and Oct. 18;
 - All calls will be held at noon (12:00 p.m. Central).
- Develop a Just Culture Algorithm;
- Administer the Safety Together National Action Plan for Patient Safety Self-Assessment in Q3-Q4 2023; and
- Connect principles of Just Culture to the Safer Together National Action Plan for Patient Safety.

PSO PROTECTIONS:

The Just Culture Collaborative is an initiative of the LAPS PSO in partnership with the Texas A&M Rural and Community Health Institute Patient Safety Organization; therefore, all participating hospitals will need to be, or become, a member of the LAPS PSO for this Collaboration.

PUBLICITY:

Facility Participants may be listed as participating organizations on the LAPS PSO website and may communicate their participation on their own websites. No other uses, including in sales promotions, advertising, or any other form of publicity, shall be made of the LAPS PSO name or the names of its members, without the prior consent of LAPS PSO or the entity whose name is being used, respectively.

- Designate a Lead to facilitate collaborative-related activities;
- Understand what the Just Culture Collaborative Team is trying to accomplish and support them, including breaking down barriers that may exist;
- Hold all team members, including executives, accountable for implementing Just Culture and participating in the Collaborative activities; and
- Develop a Just Culture Algorithm.
